

2014 FIG Foundation Young Surveyors Fellowships



The FIG Foundation Young Surveyors Fellowships will provide funding for individuals to cover the costs to attend and participate in the 2014 FIG Congress in Kuala Lumpur, Malaysia, including attendance at all FIG Young Surveyors events during the congress.

A total of eight (8) Fellowships will be awarded. Six of the Fellowships will be distributed by regionone each to Africa, Asia, Europe, North America, Oceania and South America. The remaining two (2) Fellowships will be awarded exclusively to nationals of developing countries¹ who must be living in one of the eligible countries.

Fellowships include round-trip travel costs to Kuala Lumpur, visa (if required), accommodations, registration fees for the FIG Congress, FIG Young Surveyors events, meals, per diem allowance, FIG Foundation Dinner, FIG Gala Dinner and an FIG Commission dinner.

The XXV FIG Congress in Kuala Lumpur

The XXV FIG Congress will be held in Kuala Lumpur, Malaysia, 16-21 June. In addition to congress events young surveyors sessions will be organised and contribute to the networking of young surveyors internationally, to introduce young surveyors to the FIG Congress and FIG community, and to provide for the opportunity to learn more and share the young surveyors' vision for the future of FIG.

Guideline Notes for Application

Conditions

The following conditions apply for the Fellowships:

- Applicants must be active within their local surveying professional body OR demonstrate a
 willingness and ability to be active in representing youth and the surveying profession in the
 future. Applicants are expected to continue as active contributors to the FIG Young
 Surveyors Network following attendance.
- 2. Applicants must be working or studying in the field of surveying, as defined in the FIG Definition of the Functions of the Surveyor (see www.fig.net/general/definition.htm).
- Applicants must be 'young surveyors', being 35 years or under on the application closing date OR having graduated from a Bachelor or Master Degree program no earlier than 1 December 2003.
- 4. Applicants must submit a short paper², video³, or poster⁴ on the topic "Young Surveyors' Vision for the Future of the Profession". All presentations must be in English.

 Note from the FIG Young Surveyors Network: The aim of this submission is to hear your ideas on what the future of surveying may look like so be creative! Think about the role of FIG what should such an organisation strive to achieve? We also want to hear how you intend to play a role in this future what would you do to encourage young surveyor, and how will young surveyors create this future? Remember: we want short, to the point answers so feel free to use bullet points or alternative formats like video or posters.
- 5. Applicants must submit two written references and provide the contact details of two referees, ideally one current employer and one current or previous academic supervisor.
- 6. The closing date for applications is **1 December 2013**. All applications must be received by this date.

Procedure for applications

All applicants for the FIG Foundation Young Surveyor Fellowships must, in addition to the required presentation as noted above, supply the following information (all information must be legible):

- 16) TWO WRITTEN REFERENCES WITH CONTACT DETAILS AS NOTED ABOVE

- All submissions must be in English.
