Setting the Scene

The 2024 FIG Working Week was held between 19 to 24 May in Accra, Ghana (<u>https://www.fig.net/fig2024/</u>) at the Royal Palm Beach Resort. The event was hosted jointly by Licensed Surveyors Association of Ghana (LISAG, <u>www.lisagh.org/</u>) and The Ghana Institution of Surveyors (GhIS <u>www.ghisonline.org/</u>), demonstrating that collaboration is our superpower!

This was the second Working Week for the 2023-26 period, under the Presidential leadership of Diane Dumashie. The content presented here focuses mainly on the activities, sessions, and outcomes for FIG Commission 7 (C7). This was also the second time Ghana hosted a FIG event, the previous being a regional conference in 2012 in Elmina.

The Program

The 2024 Working Week was a very full program for C7, in fact, we were running the most sessions of all the Commissions. Every C7 Working Group had its own session, and beyond that, we also had extra sessions and a good number of joint sessions organized jointly with other commissions and/or networks and partners. This meant C7 had well over 100 papers presented at the conference. In total, we had 19 sessions:

Israel Taiwo, Chair of WG 7.2 also organised a side-event on FFP, enhancing discussions on "Adapting, Adopting and Evolving Approaches to Land Administration; Towards Effective Upscaling of FFP Approaches." There were approximately 20 in attendance. The results of the workshop are feeding into the planned FIG publication that will act as a complimentary update to the 2014 FIG FFPLA Overview publication and the 2016 FFPLA Guidelines publication (a collaboration with UN-Habitat and GLTN).

C7 Meeting and Joint Dinner

C7 also ran its dedicated meeting on Tuesday 21th May. Great to see so many long-time and newer face joining the meeting, even though the meeting room location remained secret until last minute! In the meeting, we provided an introduction to Commission 7 for the newcomers, and a status check for cadastre, followed by presentations of the Working Groups and Chairs, the plans for Annual Meeting 2024 in Kuching, Malaysia, and continued our discussion over lunch afterwards.

The dinner was a joint one with Commissions 8 and 9. This meant that the C7 world-famous song was not played. Instead, we had a perfect musician from the house, who played a brand-new song to address the whole FIG community – including dedicated verses for Stig Enemark ("the FIG Legend"); our awesome sponsors esri, Leica, and Trimble; and even least-squares adjustment. As always, it was a really fun evening with a lot of inter-commissional dance moves, laughter, and pleasingly no (known) casualties.

Wrap-Up
