COMMISSION 8 @ THE 2025 FIG WORKING WEEK IN BRISBANE, AUSTRALIA.






The 2025 Working Week in Brisbane Australia saw Commission 8 organising five technical sessions covering women's land rights and access to land, digital transformation, geospatial intelligence, land management and spatial governance, climate resilience, disaster risk management. Over fifty papers presented and discussed. The commission also had joint sessions together with other sessions.

Key Take Aways from our sessions:

- Innovation requires studying communities holistically, including both technical and social elements and impacts of land and geospatial tools.
- Digital Technologies can foster collaboration between various disciplines of surveying towards a more connected and resilient society.
- Integration of inclusive practices in spatial governance, paves the way for a more resilient and harmonious society, where everyone can thrive."

COMMISSION 8 @ THE WORLD BANK LAND CONFERENCE 2025



The FIG Commission WG 8.1 was represented at the World Bank Land Conference held in Washington DC on 4 to 6 May, 2025. The Working Group jointly hosted the session titled, "Securing Land for Climate Action in Africa: Ideas, Concepts and Experiences", with the Global Land Aliance (GLA), the Youth Initiative for Land in Africa (YILAA), the Network for Excellence on Land Governance for Africa (NELGA), the Global Land Tool Network (GLTN), GIZ, University of East London, and the Namibia University of Science and Technology. FIG was represented by the President, Diane Dumashie, WG8.1 Chair, Prof. Eugene Chigbu, and WG 8.1 Co-Chair, Dr. Jennilee Kohima. The session brought together science-policy knowledge, via a panel, to build continental, national, and local climate action in Africa. The session brought together academia, civil society, government institutions, professional organisations, and the private sector to contribute to the discourse.

COMMISSION 8 ANNUAL MEETING IN ROMANIA

The FIG Commission 8 will join the Romanian Surveyors Union (RSU) for the 6th Romanian Surveyors' Week (RSW) in Timişoara, Romania, on 21st to 25th of October 2025, on the ULST Campus.









The event will be held in partnership with the Faculty of Civil Engineering from Polytechnical University Timişoara (FCPUT) and the Faculty of Agriculture from University of Life Science "King Mihai I" from Timişoara (ULST), and in collaboration with FIG Commission 2, the National Agency for Cadastre and Land registration (ANCPI).

The Commission 8 Annual Meeting will be held during the week, under the theme, "Responsible Knowledge Transfer and Innovation in Land and Spatial Governance". The general theme of the International Conference, "Geospatial technologies for sustainable development of agriculture and built environment", will bring together specialists from geodesy, surveying, cadastre, professional education, special planning and administration, agriculture, GIS and other related fields.
