## 1. General

In an service oriented information society the management of spatial information becomes an integral part of the business processes with human interaction as core using geo-tools and geo-data for shaping services. Parallel to that the public sector follows the same development with e-Government initiatives as trigger. FIG Commission 3 contributes to that development of integrating Spatial Information Management.

### 1.1 Mission

The mission of Commission is:

- Bringing awareness to successful Spatial Information Management (SIM) approaches in the “Information Age” for better decision making. Decision makers on all levels nowadays expect reliable spatial information and not only maps.
- Supporting the use of SIM-tools for decision makers and citizens to support the goals of participatory democracy.
- Share good practice on managerial processes and infrastructure needs for handling data, using information and distributing knowledge.
- Encouraging decision-makers for a more extensive use of spatial information in compliance with developments within e-government and e-commerce.

Criterion of success has been defined as:

- To initiate and provide activities so interesting that colleagues will regard the commission as one base on their professional lives.
- Progress activities mainly through working groups (WGs) and joint working groups (JWG), which contribute to workshops and seminars held during and outside FIG working weeks; submit progress reports about these events.
- Present the final outcomes of Commission work as reports, statements and/or publications accessible also through the web.

## 1.2 Work plan 2002-2006

The Commission 3 work plan is founded on the wider objectives defined in the FIG Councils' work plan.

Commission 3 work plan focuses on contribution of spatial information for sustainable development. The following elements for achieving this goal formed the base for the Working groups of Commission 3:

- “**e-Government and e-Citizen**” focusing on the interactive information flow between providers, partners and customers (PPP);
- “**SIM infrastructure**” for harmonization of data, information, tools (LBS) and workflows;
- „**State of the art of SIM**“ for sharing experience best practice;
- “**Knowledge in SIM**” provides the overarching principle for sharing and transferring knowledge achieved.

### 1.2.1 Implementation

According to the Work plan Commission 3 aimed at addressing these issues in various activities and structured the tasks into the following working groups:

#### **Working Group 3.1: e-Government and e-Citizen**

The decision of Commission 3 of focusing on those topics proved to be full in line with the development of increasing development in the e-government field. The pre-Conference Workshop as well as the session during Cairo WW focused on *SDI Legal and Policy Issues* and addressed the requirements for a *spatial component of e-Government*. The final result can be summarized as:

- WG3.1 members encouraged experts to present at various conferences good examples of e-government programmes where GI is an essential component.
- WG3.1 initiated and shaped the Cairo - Pre-Conference Workshop **WSE 1 – e-Government for e-Citizens: State of the Art on e-Government Initiatives**.

A position paper summarizing the progress is under development.

#### **Working Group 3.2 - SIM infrastructure**

Activities on SIM infrastructure resulted in several workshops:

- Milestones of the work of WG3.2 ‘**SIM infrastructure**’ have been the conferences on *Improving the Positional Accuracy of GI Databases*, in Dublin in May 2004 ([www.dit.ie/eurocdr](http://www.dit.ie/eurocdr)), and in Munich in June 2005 ([www.geodaten.bayern.de/bvv\\_web/geodatenonline/fachanwender/aktuelles\\_EuroSDR2005.html](http://www.geodaten.bayern.de/bvv_web/geodatenonline/fachanwender/aktuelles_EuroSDR2005.html)), which was organized by EuroSDR jointly with WG3.2.
- In October 2006 a pre-conference workshop of COM3+5+7 will focus on *Quality Management for Geodata* will be held on the FIG-congress in Munich.

The outcome has been published within proceedings as well as on the web.

### **Working Group 3.3 - State of the art of SIM**

The outcome of this WG resulted in:

- An additional outcome has been the joint UN/ECE-WPLA, FIG Commission3 + 7 conference on "Spatial Information Management for Sustainable Real Estate Market "in Greece in June 2003.
- Chryssy Potsiou - as member of WPLA-steering board - and other Commission 3 members contributed to the publication: "*Land Administration in the ECE region - Development Trends and Basic Principles*".
- WG 5.4 - Cost Effective Surveying Technology and Techniques for Developing Countries has been supported by Chryssy Potsiou.

Most of the outcome has been published within proceedings as well as on the web.

### **JWG 3.4 - Knowledge Transfer in SIM**

In April 2006 in Budapest, Commission 2+3+7 presented on a joint workshop on "*e-Governance, Knowledge Management and e-Learning*" ([www.fig.hu](http://www.fig.hu)) the outcome of Knowledge transfer in SIM and published the results within proceedings as well as on the web.

### **JWG of Commissions 3 and 7 on "3D-Cadastre"**

From Commission 3 point of view 3D-Cadaster is a milestone towards a multidimensional (geo-spatial and multi-temporal) information management. The WG intends to publish during the 2006 Congress in Munich a FIG publication on guidelines to establish a 3D Cadastre, addressing legal, technical and institutional issues. Several papers at the WW in Cairo are focusing on the multidimensional approach summarized up to now under "3D Cadastre".

The outcome has been published within proceedings.

### **JWG of Commissions on Informal Settlements**

This activity will result in a joint workshop with UN-ECE-WPLA in 2007.

## **1.3 Communication and information exchange**

Commission 3 contributes to Spatial **Information** Infrastructure which is considered as a wider approach than the Spatial **Data** Infrastructure. The cooperation with the thematic neighbouring GSDI-organisation resulted in a joint FIG-GSDI-Working Week 2005 in Cairo. Last but not least Commission 3 promoted inter- and trans-disciplinary cooperation which is explained later on within the chapter on cooperation with sister organisations and with UN-bodies.

The internal information exchange and information management within Commission 3 was always an important issue during these years. The commission officers understood their contribution also as focal point for information sharing. Thus, the network of commission 3 community communicates intensively by emails on any upcoming requests from members. In addition Reinfried Mansberger ([mansberger@boku.ac.at](mailto:mansberger@boku.ac.at)) Vice-Chair - Administration and Information of commission 3 coordinated these activities and maintained the content of our Commission 3 website ([www.fig.net/figtree/commission3](http://www.fig.net/figtree/commission3)).

### 1.3.1 Commissions 3 digital Newsletter

Every year Commission 3 produced one CD containing publication, information, news, and links related to Spatial Information Management. About 500 copies of these CDs have been sent each time to beneficiaries all over the world including delegates, correspondents, academic members and to other persons within the international FIG Commission 3 community.

### 1.3.2 Beneficiaries

The beneficiaries addressed are as such:

- Surveyors, surveyors associations and users engaged with spatial data and spatial information;
- Citizens accessing and contributing to e-Government on national as well as on a local level;
- The educational sector, involving spatial information into their learning and training environment.

### **2.2 Cooperation within Sister Associations**

Cooperation with **GSDI**: Commission 3 held close cooperation with GSDI contributing to 6<sup>th</sup> GSDI Conference in Budapest, 16-19 September 2002 as well as initiating the joint FIG-GSDI-event in Cairo 2005.

Cooperation with **ISO / CEN**: Prof. Dr.-Ing. Hans Knoop, member of Commission 3 contributed to international standards on spatial data with ISO and OPENGIS acting as co-chair of the Advisory Groups on Outreach of ISO/TC 211 and CEN/TC 287.

Cooperation with **EuroSDR**: Joint workshops with EuroSDR have been held on *Improving the Positional Accuracy of GI Databases*, in Dublin in May 2004 and on *Shifting maps for better quality*, Munich, June 2005.

Cooperation with **ICA**: Keith Murray, Chair of Commission 3 WG 3.2, attended the 21<sup>st</sup> International Cartographic Conference of the International Cartographic Association (ICA), in Durban, South Africa, August 2003.

Cooperation with **South American countries**: Erwin Heine, Institute of Surveying, Remote Sensing and Land Information at the University of Applied Life Sciences in Vienna represented FIG at the 2<sup>nd</sup> International Conference on GIS in Bogotá, Colombia September, 2003.
