Member of the Chamber of Graduated Surveyors could be any physical person, who is Bulgarian citizen and had graduated surveying according to § 1, p5 of Transitional and concluding provisions of Law of Geodesy and Cartography or foreign physical person with recognized and licensed degree according to art 9, para. 3, p. 9 and art 10, para. 2, p. 4 of the Law of Higher Education, could be accepted as a member of the Camber of Graduated Surveyors.
- 3. To become a member you have to submit an application for approval to The Managing Committee
 - 4. Members of the Chamber of Graduated Surveyors has the rights:
 - 1. To votee and to be voted for in the Executive bodies of the Chamber;
 - 2. To put forward proposals and recommendations and to disagree with decisions of the Managing committee which concerns the Chamber.
