Software Capabilities:

- Land Plot Cadastral Map, with respective boundary lines, GPS points, building description and other cadastral information;
- Data on the owners, interested persons, family members, household members. Information is directly linked to the Public Service Development Agency database and it automatically
 generates information if the ID information is entered in the respective fields;
- Ownership Data, Area According to the respective legal documents, data on the title documents and possibility to attach the electronic copy if needed;
- Data on other residents of the registration block, bordering land plots etc;
- Land usage data, information on crops, buildings etc. which is generated from GIS;
- Electronic Signatures and etc.

National Rollout



January 01, 2022 – Launch of the National Rollout of Systematic Land Registration January 01, 2025 – Intended Completion Date

General Information:

- Total Budget of 120 Million GEL
- Full Cadastral coverage of Georgia;
- SLR will be completed in 59 municipalities, excluding 5 major cities.
- Additional 1.335 Million Hectares / 1.9 Million Plots will be registered

Land Consolidation - Existing Situation

Land Reform 1992-1998

- State ownership of land during Soviet Union was followed by **nation-wide privatization**;
- Land reform resulted in excessive fragmentation of both land ownership and land use:
- \checkmark Each family was given a land in 4-5 plots, average size 0,25 ha each;
- \checkmark The distance between plots in same cases 5-10 km.;
- As a result 1,300,000 households (approximately 3.5 million citizens) became owners of small plots of land.



Example of one Municipality (Dedoplistskaro)

- Total area 46,000 ha.
- Before 1992 there were 560 plots,
- After reform land was divided into 26,000 plots.

Land fragmentation is a problem for the state:

- Limitations for conducting common agricultural policy, increased costs and reduced efficiency;
- Fragmented agricultural services, including fragmented irrigation and drainage systems;
- Need for construction of additional internal agricultural roads at the expense of fertile lands.





Farmers are primarily affected by land fragmentation:

- Land productivity decreased;
- Costs for agricultural production increased.

Systematic Land Registration

Systematic Land Registration Reform History

- Since 2016 Georgia started systematic land registration reform in parallel to sporadic registration;
- Since 2022, the systematic land registration is national project.

Implemented Activities

- Competent authorities defined, functions and duties were distributed;
- Their technical, human and financial capabilities were developed;
- Pilot projects were implemented;
- Land registration methodology was tested and established;
- Legislation was improved and adopted.

Land Consolidation

Land consolidation Reform Initiative

- Sporadic Land Consolidation should be backed by Systematic Land • Consolidation reform:
- Land Consolidation should become a national project. •

Land consolidation Reform Initiative

- Competent authorities are in place, functions should be clearly assigned; •
- Their technical, human and financial capabilities should be developed;
- Pilot areas should be defined and projects implemented;
- Land Consolidation methods should be defined, tested/established;
- Legislation should be drafted;

• Land consolidation component added to Systematic Land Registration Reform.



Land Consolidation

Further Actions

- Develop and implement Land Consolidation National Program;
- Conduct a country-wide multi-criteria assessment to identify the most feasible areas for land consolidation in Georgia;
- Consolidation process effectively linked with land-related or other infrastructure projects (rehabilitation of amelioration systems, rehabilitation of windbreaks, road construction etc.).
- Regulations to avoid further fragmentation.

Land Consolidation Feasibility Study



FAO will assess the opportunities for land consolidation:

i) as a standalone activity;

ii) Combined with amelioration and

iii) Combined with systematic land registration





Develop recommendations on legal and institutional framework for introduction of land consolidation/implementation of pilot projects.
